

## FMCSA Licensing and Insurance Register

The following requests for authority have been reviewed by the Federal Motor Carrier Safety Administration (hereafter, the Administration) and are being published as preliminary grants. These grant decision notices do not represent authority to operate.

Applicants will be sent a letter on the day when notice of their application appears in the FMCSA Register. This letter informs them of their docket number, their insurance and process agent filing requirements and deadlines, and the publication date in the Register.

Legally sufficient opposition, in the form of verified statements, must be filed within 10 days of the date of publication in the Register.

In the absence of opposition, authorities will be issued to those applicants that have filed evidence of appropriate compliance within 20 days of date of publication.

Applications that are not supplemented with the required insurance and process agent filings by the 20th day following publication in the FMCSA Register will be dismissed. Dismissal notices will be issued to non-complying applicants on the 30th day after publication in the FMCSA Register.

Authorities will remain in full effect only as long as the applicant maintains appropriate compliance.
