Feds halt licensing of new bus companies Move is response to Texas crash that killed 17

DALLAS - The federal government says it will temporarily stop granting licenses to new bus companies after a crash in Texas killed 17 people.

The head of the Federal Motor Carrier Safety Administration told The Associated Press on Tuesday he wants all applications to be checked against a database of bus companies that were given out-of-service orders.

Iguala BusMex Inc., whose bus crashed near Sherman on Friday, was awaiting approval for a federal license. The company is run by a man who also operates Angel Tours Inc., which was forced to take its vehicles out of interstate Service June 23 after an unsatisfactory review by federal regulators.

Agency head John H. Hill said the suspension will not be "for a long period of time."

Effective March 8th, 2007, the following changes for MC/FF/MX numbers can no longer be made to the Licensing and Insurance web site: (1) Operating Authority Name changes, (2) Operating Authority Address changes, (3) Operating Authority Transfers, and (4) Operating Authority Voluntary Revocations.

FMCSA Licensing and Insurance Register

Requests may also be made by contacting the contract agent at (240) 632-8591 [FAX: (240) 632-8592] and arranging billing as acceptable to the agent.

Applicants will be sent a letter on the day when notice of their application appears in the FMCSA Register. This letter informs them of their docket number, their insurance and process agent filing requirements and deadlines, and the publication date in the Register.

Legally sufficient opposition, in the form of verified statements, must be filed within 10 days of the date of publication in the Register.

In the absence of opposition, authorities will be issued to those applicants that have filed evidence of appropriate compliance within 20 days of date of publication.

Applications that are not supplemented with the required insurance and process agent filings by the 20th day following publication in the FMCSA Register will be dismissed. Dismissal notices will be issued to non-complying applicants on the 30th day after publication in the FMCSA Register.

Authorities will remain in full effect only as long as the applicant maintains appropriate compliance.

Notice

The Federal Motor Carrier Safety Administration (FMCSA) is notifying the public that the timeframe required to revoke a carrier's operating authority for failing to have sufficient levels of insurance on file is being reduced. The current process takes at least 66 days. The new 33 day process will only allow a carrier to hold operating authority without insurance reflected on our Licensing and Insurance database for up to three (3) days. Revocation decisions will be tied to our enforcement program which will focus on the operations of uninsured carriers. This improvement will further ensure that the public is adequately protected in case of a motor carrier crash. Accordingly, we are adopting the following procedure for revocation of authority: 1) The first notice will go out three (3) days after FMCSA receives notification from the insurance company that the carrier's policy will be cancelled in 30 days. This notification informs the carrier that it must provide evidence that it is in full compliance with FMCSA's insurance regulations within 30 days. 2) If the carrier has not complied with FMCSA's insurance requirements after 30 days, a final decision revoking the operating authority will be issued.
