Mr. LANGWORTHY introduced the following bill; which was referred to the Committee on _____

A BILL

To prohibit engine idling restrictions for over-the-road buses and school buses if an engine idles for less than 15 minutes, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Buses Utilizing Safety
5 and Environmental Standards Act” or the “BUSES Act”.

1 **SEC. 2. NATIONAL MINIMUM IDLING STANDARD FOR**
2 **BUSES.**

3 (a) IMPLEMENTATION PLANS.—Section 110(a) of the
4 Clean Air Act (42 U.S.C. 7410(a)) is amended by adding
5 at the end the following:

6 “(7) ENGINE IDLING RESTRICTIONS.—Notwith-
7 standing any other provision of this Act, no imple-
8 mentation plan submitted by a State under this sub-
9 section may include, nor may any State, or political
10 subdivision thereof, enforce through such implemen-
11 tation plan, any engine idling restriction applicable
12 to the idling of an engine of an over-the-road bus (as
13 defined in section 304(h)(3)) or a school bus for a
14 period of less than 15 minutes.”

15 (b) CITIZEN SUITS.—Section 304 of the Clean Air
16 Act (42 U.S.C. 7604) is amended by adding at the end
17 the following:

18 “(h) LIMITATION ON ACTIONS RELATING TO IDLING
19 OF BUSES.—

20 “(1) IN GENERAL.—Notwithstanding any other
21 provision of this Act, no person may commence a
22 civil action against an owner or operator of an over-
23 the-road bus or a school bus for any alleged viola-
24 tions of engine idling restrictions described in sec-
25 tion 110(a)(7).

1 “(2) PROHIBITION ON BOUNTY-BASED EN-
2 FORCEMENT PROGRAMS.—Notwithstanding any
3 other provision of law—

4 “(A) no State or political subdivision
5 thereof may implement or maintain any pro-
6 gram that provides monetary compensation to
7 private individuals contingent upon the report-
8 ing, citation, or enforcement of engine idling
9 violations for over-the-road buses; and

10 “(B) any such program that is in effect on
11 the date of enactment of this subsection shall
12 be terminated not later than 180 days after
13 such date of enactment.

14 “(3) OVER-THE-ROAD BUS DEFINED.—The
15 term ‘over-the-road bus’ has the meaning given such
16 term in section 301 of the Americans with Disabil-
17 ities Act of 1990 (42 U.S.C. 12181).”.
